**Roadmap to Help California's Post-Secondary Education
Systems Recover from Pandemic More Equitable and Better
Positioned to Serve All Students**

SACRAMENTO, CALIFORNIA—A new report and set of recommendations aimed at helping California's post-secondary systems recover from the pandemic and better serve the state's students was submitted to Governor Gavin Newsom and the [Governor's Council for Post-Secondary Education](#) today.

[Recovery with Equity: A Roadmap for Higher Education After the Pandemic](#), was produced by a [Recovery with Equity Taskforce](#) established last summer by Dr. Lande Ajose, Governor Newsom's senior policy advisor for higher education, in consultation with the Governor's Council for Post-Secondary Education.

"California's post-secondary systems cultivate talent that is needed to chart our state's course to future economic prosperity," said **Governor Gavin Newsom**. "This roadmap will help our colleges and universities build up systems that will better serve all students. Preparing Californians with the training and education necessary to engage in high-quality, in-demand jobs will drive a recovering, vital economy. Strengthening our postsecondary systems while eliminating disparities of credential and degree attainment by race and geography will lead to a stronger and more resilient California for All."

Dr. Lande Ajose, who also chairs the Governor's Council for Post-Secondary Education, said, "Student success in higher education is critical to the health of our state and regional economies. We need to ensure that California's systems of higher learning fully recover from the pandemic and thrive, while keeping students our number one priority. Their success is inextricably tied to the future of California."

The *Roadmap for Higher Education After the Pandemic* includes a series of interconnected, interdependent recommendations developed by the Recovery with Equity Taskforce to help post-secondary systems emerge from the pandemic stronger and better able to help all learners thrive. The recommendations in the report are organized to advance four guiding principles:



Fostering Inclusive Institutions: Institutional cultures and approaches to teaching and learning that work for all learners, especially those left behind.

1. Improve Faculty, Staff, and Administrator Diversity
2. Cultivate Inclusive, Engaging, and Equity-Oriented Learning Environments
3. Retain Students through Inclusive Supports

Streamlining Pathways to Degrees: An integrated statewide system for admission and transfer to provide clear, easy-to-navigate pathways to degrees.

4. Establish an Integrated Admissions Platform
5. Streamline and Unify the College Admission Process
6. Develop a Common Course Numbering System

Facilitating Student Transitions: High-touch, high-tech guidance and improved academic preparation for college access and success.

7. Provide High-Tech, High-Touch Advising
8. Support College Preparation and Early Credit

Simplifying Supports for Student Stability: Resources and structures packaged and simplified to help students meet basic, digital, and financial aid needs.

9. Establish an Integrated Admissions Platform
10. Subsidize Internet Access for Eligible Students
11. Improve College Affordability

The Recovery with Equity Taskforce that developed these recommendations included [California and national experts in higher education equity and innovation](#). Taskforce deliberations were informed by interviews and focus groups with a broad swath of students and K-12 and post-secondary educators, as well as leaders in civic organizations, local governments, nonprofits, and workforce development.

The Recovery with Equity Taskforce report concludes with actions that leaders in California can pursue to support California's post-secondary institutions recover from the pandemic more equitable and resilient than before, and more aligned with the economic needs of the state.
